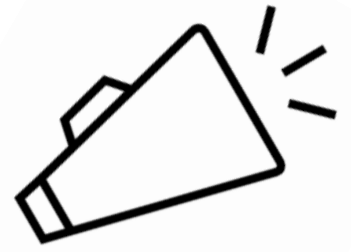


"Stay at Home" Order Announcements States Begin to Re-Open

Announcement on State's Release Dates

Alabama:

- Set to Expire: May 15th

Alaska:

- Set to Expire: May 20th

Arizona:

- Set to Expire: May 15th Extension

Arkansas:

- May 4th: Gyms, fitness centers and athletic clubs can begin to reopen
- May 6th: Barber shops, cosmetology, massage therapy, spas can begin to open
- May 11th: Dining will begin operations with 33 percent capacity.

California:

- Set to Expire: TBD

Colorado:

Reopens will begin on May 1st with restrictions and regulations to follow. Below are the businesses that will begin to reopen.

- ❖ Salons, parlors
- ❖ Dog grooming and pet stores
- ❖ personal training and trainers
- ❖ Elective medical and dental

Connecticut:

- Set to Expire: May 20th

Delaware:

- Set to Expire: May 15th

Florida:

- ❖ Currently Phase 1:
- ❖ Restaurants may offer outdoor seating with 6ft spacing and 25% capacity indoor.
- ❖ Retail can open at 25% capacity

Georgia:

Businesses that have begun to reopening include:

- ❖ Gyms and fitness centers
- ❖ Bowling alleys
- ❖ Barber, Hair and Nail salons
- ❖ Tattoo Parlors
- ❖ Esthetician and Massage therapist
- ❖ Restaurants
- ❖ Theaters

Hawaii:

- Set to Expire: May 31st

Idaho:

- May 1st: Begin Phase 1, which includes places of worship, daycares and youth activities to reopen
- May 16th: Phase 2 will begin

Illinois:

- Set to Expire: May 30th
- What has reopened: Golf courses, State parks, retail stores and garden centers

Indiana:

Entered State 2 on May 4th, which will open:

- ❖ Retail and commercial business can open at 50% capacity
- ❖ Shopping malls can open at 50% capacity
- ❖ May 11th salons, barber shops, spas and tattoo parlors can open by apt.
- ❖ May 8th places of worship can begin to hold services

Iowa:

- Set to Expire: April 30th
- Announcements coming this week

Kansas:

- Phase 1 has begun as of May 4th, which includes:
 - ❖ Libraries
 - ❖ Childcare facilities

Kentucky:

Reopens begin in Phase 1 with:

- ❖ May 11th: Dealerships, professional services at 50% capacity
- ❖ May 20th: Retail and Houses of worship can open
- ❖ May 25th: Barbers, Salons, Cosmetology businesses
- ❖ Pet grooming and boarding

Louisiana:

- Set to Expire: May 15th extension

Maine:

- Set to Expire: May 31th
- May 1st Barber shops, Hair Salons, Auto Dealers, Drive in Religious services

Maryland:

- Beginning May 7th golf, tennis, boating, fishing, camping can resume
- Beaches and state parks will reopen

Massachusetts:

- Starting on May 18th the state will begin to reopen some businesses

Michigan:

- Set to Expire: May 15th
- Reopened: Boating and outdoor recreation, Golf Courses, Bike Repair Shops, Plant Nurseries and garden centers

Minnesota:

- Set to Expire: May 18th - curbside pick up available

Mississippi:

- Retail can reopen at 50% capacity
- Elective surgeries can resume

Missouri:

Beginning May 4th businesses began to reopen, which include:

- ❖ Places of worship
- ❖ Daycares and childcare facilities
- ❖ Theaters, parks, funerals, museums
- ❖ Retail and Dining rooms, with capacity requirements

Montana:

May 4th business can begin to reopen which include:

- ❖ Outdoor recreation facilities
- ❖ Retail
- ❖ Churches
- ❖ Childcare facilities
- ❖ Restaurants, breweries, casinos with curfew
- ❖ Schools (May 7th)

Nebraska:

Businesses are able to reopen May 4th which include:

- ❖ Barber shops, salons, tattoo parlors
- ❖ Religious services
- ❖ Restaurants and dining with 50% capacity
- ❖ Dental and veterinary services can reopen

Nevada:

- Place of worship can hold drive-in
- Beginning May 1st, retail for curbside pickup service

New Hampshire:

- May 11th: Retailers can open with customers in stores
- May 18th: restaurants and open with outdoor seating

New Jersey:

- Set to Expire: TBD
- Here is what is open: Grocery stores, gas stations, hardware stores, pet stores, banks, laundromats, liquor stores, mobile phone retailers, bicycle shops, nurseries and garden centers

New Mexico:

- ❖ Set to Expire: May 15th
- Some businesses have reopened which include:
 - ❖ Childcare for non-essential businesses
 - ❖ Pet services
 - ❖ Golf courses
 - ❖ Gun stores by appointments
 - ❖ state parks can open for day-use

New York:

- Set to Expire: May 15th

North Carolina:

- Set to Expire: May 8th: Childcare facilities open

North Dakota:

- ❖ Phase 1 is in the process and protocols are being made for theaters, restaurants, salons, and more
- ❖ Campgrounds will reopen and on May 21st all parks will be open for season

Ohio:

- Set to Expire: May 29th
- Dentist, Veterinarian offices, Manufacturing, Distribution, construction are able to all reopen
- May 12th - Retail set to reopen

Oklahoma:

- ❖ State parks and outdoor recreation can reopened
- ❖ May 1st: Dining rooms, restaurants, movie theaters, gyms and sporting venues can reopen
- ❖ Places of worship can open
- ❖ Tattoo parlors can open with appointment only

Oregon:

- Set to Expire: TBD
- Hospitals, surgical centers, medical offices able to open as of May 1st.

Pennsylvania:

- Set to Expire: May 8th
- Golf Courses, Marinas, Guided Fishing, Private Campgrounds are open

Rhode Island:

- ❖ Stay at home Order will be lifted on May 8th. May 10th, non-essential retail businesses can reopen
- ❖ State parks and beaches will also be reopened

South Carolina:

- ❖ Restaurants many begin reopening May 4th with outdoor seating
- ❖ Department stores and retail can open with limited capacity, this includes book stores, music stores and sporting goods

South Dakota:

- Set to Expire: May 31st

Tennessee:

- ❖ Restaurants and retail can begin reopening at 50% capacity
- ❖ Gyms and fitness centers can reopen this month

Texas:

- ❖ Businesses that have filled for DSHS can begin to operate at 50% capacity;
- ❖ Retail services, dine-in restaurants, movie theaters, shopping malls, museums, libraries

Utah:

- ❖ Can begin reopening: Restaurants and in-house dining
- ❖ Gyms and fitness centers will open

Vermont:

- ❖ Can begin reopening: retail and libraries, farmers markets

Virginia:

- Set to Expire: June 10th

Washington:

- Set to Expire: May 31th
- Washington did open ; Golf courses, State parks and outdoor recreation (Fishing and Hunting)

West Virginia:

- As of May 4th,
 - ❖ Restaurants can open for outdoor service and takeaway
 - ❖ Pet groomers can open
 - ❖ Barber shops, hair and nail salons can open
 - ❖ Churches

Wisconsin:

- Set to Expire: May 26th

Wyoming:

- State is open!
